Price County has **7 municipalities** that collect all current property taxes through **July 31<sup>st</sup>**

**Towns Emery, Georgetown, Harmony. Lake, Village of Prentice & City Phillips:**  
Payment installments are : January 31 - 25%, April 30 - 25%, July 31 - 50%

**TOWN OF CATAWBA :** January 31 - 10%, April 30 - 40%, July 31 - 50%

Below are listed the municipalities that are involved in multiple installment collections. All **current** year taxes in these municipalities are paid to the *local treasurers through July 31<sup>st</sup>*. As of **August** each year all unpaid taxes become delinquent and payments along with interest and penalty at 1.5% per month from February 1 are made to **Price County Treasurer**.
